



HOME HOMEBUYER DEVELOPMENT

> Key Components

- New Construction OR Rehab
- 4 homes/units or less
- Nonprofit housing developers
- Maximum Award \$1,000,000
- Maximum Per Unit is \$250,000 or up to the Max Per Unit HOME Subsidy, whichever is less
- Once completed the unit must be sold to a HOME eligible buyer (at or below 80% of AMI)



CDBG IMMINENT THREAT

> Key Components

- Address conditions that negatively impact community health or safety
- Types of Projects:
 - Repairs or improvements to water/sewer systems,
 storm sewer drainage, flood walls, roads, sidewalks
 - Demolition and/or clearance of damaged structures
 - Public services required as a result of disaster
- Maximum Award \$1,000,000



STATE FUNDED REHAB HIGHLIGHTS

ACCESS TO HOME ELIGIBLE ACTIVITIES

Habitability

Beginning with the 2024 Funding Round, Access to Home, Access to Home for Heroes, and Access to Home for Medicaid Members allow 40% of each project to be accessibility repairs and 60% of each project to be habitability repairs.

STATE FUNDED MOBILE AND MANUFACTURED HOME REPLACEMENT


Budget language allows new flexibility for the state funded MMHR program.

- 2025 awardees of MMHR contracts will be allowed to exceed the \$100,000 cap on a per project basis determined with project managers during the set up process.
- This change impacts only MMHR awards to be funded in response to the 2025 funding round and forward.

More information will be provided when contract execution begins.

21 RPCs are waiting on review of applications


20 RPCs have approved applications

VACANT RENTAL PROGRAM RETURNS FOR 2025

VRP OVERVIEW

- Rehabilitate unrentable vacant units and properties
- Create long-term rental units for low- and moderate-income households
- > Small buildings (5 or fewer units) outside of NYC
- ➤ 10-Year Restriction tenant household income & max rent limit
- > Grants to property owners up to \$75,000 per unit




Conversion of commercial/other vacant buildings up to 5 units

- Flexible to address different housing stock
- Prioritization
 projects based on local needs and organizational priorities

#2 — TENANT-FRIENDLY

- > Landlord screening
- > 80% AMI but incentive for 60% AMI
- > Right to renew lease
- > Max rent limit
- > Still attractive to owners



#1 - AVAILABLE THIS FALL

- > \$40M Committed in 2024
- ➤ Additional \$40M Allocated in 2025
- > 2025 Round 1 Closed
- ➤ 2025 Round 2 Opening this fall
- Open to Nonprofits and local governments
