

# The Budget Dance Begins Governor Proposes Cuts To Operating Funds

In a reversal oif practice for the past 3 years, Governor Cuomo's 2018-19 state budget proposal reduces operating support for the Rural and Neighborhood Preservation Programs significantly. The budget cuts will result in the Preservation Companies being funded this year at a baseline\* of approximately \$58,000 per preservation company, unless the state legislature acts to provide additional funding in the final, enacted state budget.

The Budget Briefing Book includes some interesting policy details. In the chapters on the notfor-profit sector, the budget book describes a number of concerns that impact the effectiveness of the notfor-profit partners upon which the State relies to deliver programs and services, including workforce development and contracting efficiencies.

The Budget Book notes that notfor-profit organizations struggle to recruit workers and face higher than average employee turnover. The administration's response is a budget increase within the Medicaid silo to support minimum wage increases

\*HCR Commissioner RuthAnne Visnauskas used this term in her testimony to the Joint Legislative Budget Hearing on Housing on January 24th. for health care workers, some of whom are employed by nonprofit organizations. The State will also launch a targeted marketing campaign to support education and career development within the nonprofit sector by encouraging participation in existing scholarship and loan forgiveness programs. The Governor also proposes a human services workforce summit and create a not-for-profit Workforce Development Steering Committee to further improve not-for-profit workforce development.

The Governor also proposes to continue/expand efforts to improve the contracting environment between state agencies and the nonprofit sector. During the summer of 2017, the Governor's Lean Office began working with seven State agencies that had been identified as having the highest number of late contracts in previous years, to monitor contract execution and identify opportunities to improve processes. The Dept. of Health, OTDA, Council on the Arts, Dept. of Labor, Office of Children and Family Services, Office of Mental Hygiene, and the Department of Criminal Justice Services are covered by this initiative, which will continue through 2019.

Further, efforts are underway to standardize State contract definitions related to indirect costs in conformance with federal OMB guidance, and to set a 10% de minimis indirect rate while maintaining services and acting with available appropriations.

The Rural Advocates are monitoring budget discussions in Albany (detailed elsewhere in this issue) and have set a Legislative Conference in Albany on February 27th to draw attention to the funding needs of rural hosuing and community development agencies across the state. Stay tuned......

## Land Trust Grants Available

The New York State Department of Agriculture and Markets (the "Department") invites eligible not-for-profit conservation organizations (Land Trusts) to submit proposals for financial assistance to conduct activities that will assist counties and municipalities with their agricultural and farmland protection efforts. Applications are due March 5th.

Specifically, State funding under this grant opportunity will advance outreach efforts to subsets of landowners derived from an existing or to-be-developed viable agricultural lands inventory and screening process. Eligible outreach efforts shall focus on the utilization and conservation of agricultural lands using the following required project elements:

i. an inventory of viable agricultural lands; and

ii. a screening process; andiii. outreach activities targetedto the landowners of inventoriedparcels of viable agricultural land.

Taken together, these three inter-related project elements are intended to connect willing landowners to farmers interested in leasing or buying viable agricultural land, and to inform owners of viable agricultural land of mechanisms and available programs to protect such lands from conversion to non-farm uses. HUD is accepting applications for the Youth Homelessness Demonstration Program. Applications are due by April 17, 2018.

The goal of the YHDP is to support up to 11 communities, at least 5 of which will be rural, in the development and implementation of a coordinated community approach to preventing and ending youth homelessness, and sharing that experience with and mobilizing communities around the country toward the same end. The population to be served by this demonstration program is youth experiencing homelessness, including unaccompanied and pregnant or parenting youth, where no member of the household is older than 24.

## Save America's Treasures Grants

The National Park Service announces the availability of \$5 million in Historic Preservation Fund grants for the Save America's Treasures (SAT) program. Applications must be submitted through Grants. gov by February 21st. SAT grants provide preservation and/or conservation assistance to nationally significant historic properties and collections. Grants are awarded through a competitive process and require a dollar-for-dollar, non-Federal match, which can be cash or documented in-kind. The grants are administered by the National Park Service in partnership with the Institute of Museum and Library Services, the National Endowment for the Arts, and National Endowment for the Humanities. ### House Passes Bill To Make FSS Permanent

The House of Representatives passed HR 4258 on January 16th. The bill permanently reauthorizes the Family Self-Sufficiency Program, and combines the FSS programs for Housing Choice Voucher recipients, and public housing residents. The program will also offer new services for financial literacy and educational attainment. The bill now moves on to the Senate.

### **Rural Advocates Tackle State Budget Challenge**

The NY Rural Advocates will gather on February 27th in Albany for the annual Legislative Conference to meet with Assembly and Senate representatives regarding restoration of funding for the Rural Preservation Program, and to increase funding levels for critically-important housing and community development programs.

Blair Sebastian and Colin Mc-Knight testified on January 24th to the Joint Housing Committees on the impact of the Governor's budget proposal, decried the 35% proposed reduction in RPP funding, and requested restoration of the RPP budget to current levels.

An increase in AHC funding from \$26 million to \$35 million was also requested, reflecting the importance of homeownership programs in rural areas. An additional \$1 million increase in the HOPE/Restore program, and noting that program administrators are pressed to deliver this program at extremely tight margins.

Their budget testimony called for a second round of funding for the Small Rental Development Initiative, which was launched by HCR in 2017 with federal HOME funds. \$10 million was requested in 2018 funding for this program.

Several legislators from NYC mentioned during the hearing that foreclosure remains a huge concern in their urban districts. Sebastian and McKnight noted that home foreclosures continue to be a significant problem in rural areas of the state, as well, and support for prevention services continues to be needed.

Of course, the testimony also asked for funding for the Rural

Housing Coalition and the Neighborhood Preservation Coalition, which were ignored in the Governor's proposal. This funding is to support the technnical assistance and training work of the Coalitions.

Rural Advocates will host a Legislative Briefing and Breakfast in the Albany Room on the Concourse at the Empire State Plaza on February 27th. All Rural Advocates members are encouraged to attend. The briefing agenda will include an overview of Rural Advocates 2018 Legislative Agenda, updates on legislative action to date, a review of Tuesday's legislative appointment schedules, and tips on making the ask, to help you make the most of your time in Albany. The discussion will focus on YOUR rural housing concerns including the top priority of securing an increase in Rural Preservation funding and protecting the housing programs used in rural communities. Several leading members of the New York State Legislature are expected to attend.

A hot breakfast in the Albany Room will be followed by legislative visits in the Capitol. Plan on making appointments with your Senators and Assemblymembers and join with others from your region to remind your elected officials of the impact of your work. Rural Advocates will coordinate meetings with Legislative and Administration leaders. Please contact Rural Advocates at *nysruraladvocates @gmail.com* if you need assistance.

### In Memoriam

We are saddened to announce the passing of John Eberhard, Executive Director of Delaware Opportunitities, Inc. on January 6th. John was 70 at the time of his passing.

After serving in the Vietnam War, John earned his BA at Syracuse University, then joined the Northern Tier Regional Planning Commission, where he launched 5 weatherization programs, and wrote grants that resulted in the development of day care services, a health clinic, water and sewer systems, and economic development projects.

John became the Executive Director of Delaware Opportuniies in 1984, and doubled the size of the agency from 100 staff to the current level of 209 employees, with an annual budget of \$14.6 million. John served on the board of directors of the Rural Housing Coalition for 2 terms in the 1990s, including serving on the Executive Committee for a time.

John completed the development of a new headquarters building for Delaware Opportunities in 2005, bringing all departments under one roof for the first time. ## Report: Burden To NonProfit Sector Of Government Cutbacks

Governing.com has a new report on the intersection of State and local governments, and the nonprofit agencies they partner with to deliver social services programming, including health care, early childhood education, and housing. The report notes that the nonprofits often are struggling financially. The findings come at a time when charitable giving to nonprofits is expected to be reduced by \$13.1 billion per year as a result of the recent tax deal, and deep cuts to welfare programs that are favored by the White House.

## **HUD Announces Wholesale Review Of Manufactured Housing Rules**

The US Department of Housing and Urban Development recently announced a top-to-bottom review of its manufactured housing rules as part of a broader effort to identify regulations that may be ineffective, overly burdensome, or excessively costly given the critical need for affordable housing. For the next 30 days, HUD is accepting public comments to identify existing or planned manufactured housing regulatory actions to assess their actual and potential compliance costs and whether those costs are justified against the backdrop of the nation's shortage of affordable housing.

Shortly after taking office, the President issued Executive Order 13771 ("Reducing Regulation and Controlling Regulatory Costs"), directing federal agencies to identify or streamline regulations that are wasteful, inefficient or unnecessary. HUD Secretary Ben Carson followed the President's Executive Order by charging the Department's Regulatory Review Task Force to identify HUD's existing rules that may inhibit job creation or impose costs that exceed the public benefit.

Manufactured housing plays a vital role in meeting the nation's affordable housing needs, providing nearly 10 percent of the total single-family housing stock. It's estimated that more than 22 million American households reside in manufactured housing, particularly in rural areas

where this form of housing represents an even greater share of occupied homes. The manufactured housing industry is also an important economic engine, accounting for approximately 35,000 jobs nationwide.

HUD's regulation of manufactured housing fulfills a critical role to ensure a fair and efficient market that supplies affordable housing for households of modest incomes and protecting consumers. HUD may adopt, revise, and interpret its manufactured housing rules based upon the public's comments it receives and the recommendations of the Manufactured Housing Consensus Committee, a statutory federal advisory committee comprised of producers or retailers of manufactured housing as well as consumers, residents and public officials.
