A Good Place To Start Executive Budget Proposal Has Positive News

The 2020-2021 State Budget was proposed by Governor Cuomo on January 21st, and for the first time in recent memory the Executive's budget proposal has multiple points for affordable housing professionals to be happy about. Despite a reported \$4 billion shortfall, in a number of key categories the Governor's budget increased line items over prior years.

Rural Preservation Program; Governor Cuomo proposed a budget for the RPC network of \$5,360,000, which is the enacted budget level for 2019-2020. Assuming this number isn't reduced during the budget negotiations, it is expected that RPC contracts will remain approximately the same as for the current year. The Neighborhood Preservation Program was similarly held at the current year funding level. The Governor proposes to fund both of these programs from the Mortgage Insurance Fund.

Rural Rental Assistance Program: Governor Cuomo proposes the RRAP program at \$21 million in his budget proposal.

Homelessness: In a najor commitment to address the burgioning homelessness situation. Governor Cuomo has proposed to double the

allocation for the Homeless Housing Assistance Program this year to \$128 million. He also proposes \$5 million for an initiative to expand permanent housing for homeless veterans. A portion of the funding for this increase in homeless housing will be provided from the Mortgage Insurance Fund.

In program funding, Governor Cuomo proposed many allocations that are easily recognized from last year:

- HOPE/RESTORE: \$1.4 million •
- Access to Home: \$1 million
- Housing Trust Fund: \$44.2 million
- NY Main Street: \$4.2 million

Not included in the budget proposal was funding for foreclosure services. NY Rural Advocates has identified a need for \$20 million to continue to provide foreclosure prevention services to meet the continuing foreclosure crisis in the state. The Rural Advocates are also asking for the legislature to increase the Governor's proposals for RE-STORE by \$1 million; as well as increases for Access to Home, NY Main Street, and an increase and the inclusion of a small project set aside for SRDI in the Housing Trust Fund allocation.

The Rural Advocates have announced a Legislative Action Day on February 25th, to raise the importance of increased programmatic funding with Assemblymembers and Senators in Albany. More details on this event are found elsewhere in this issue (Page 7/8). Anyone with an interest in bringing more resources to rural New York should plan on joining this advocacy effort. Speaking with a united voice is critical to making the case that more needs to be done, and can be done to improve the quality of life in New York's rural communities.

Section 8 Draft RFP Issued For Public Comment

The New York State Homes and Community Renewal/HTFC administers over 44,000 Section 8 Housing Choice Vouchers on behalf of very low and extremely low income families in New York. HTFC is the only Section 8 program with authority to operate statewide in New York. HTFC delivers voucher services through a network of county-based vendors known as Local Administrators.

State and federal rules require that HCR procure these vendors on a periodic basis. As such, they are simultaneously releasing two draft Requests for Proposals related to LA contracts. The draft RFPs will provide potential bidders with the opportunity to comment on Scope of Work and solicitation requirements prior to these documents being finalized. The comment period will last from January 6 to February 28, 2020.

Lousiana Effort Targets Banking Deserts

One community in Louisiana is taking a creative approach to the lack of financial institutions physically located in the community. Caddo Parish (the equivalent of a County) is looking for a credit union or bank to partner with on the development of bank branches in banking deserts (neighborhoods without access to bank branches and large concentrations of residents with limited mobility, such as senior citizens). Caddo Parish has around \$144 million in cash and investments, and plans to deposit some of those funds with participating financial institutions.

Banking desert neighborhoods in Caddo Parish have been found to be targets for predeatory lenders, payactual RFPs sometime later in 2020 and seek bids from local government, nonprofit and private entities to serve as LAs under multi-year contracts. The timing of the RFP and the terms of the contract are subject to change at HTFC's discretion. HCR staff will not be permitted to respond to inquiries regarding the Draft RFPs or any future solicitation. All comments and suggestions should be directed to *LA-RFP@nyshcr:org*. However, staff will continue to support and engage the current network of LAs on all other matters related to Section 8. Staff will work together with partners to continue delivering vital housing assistance to families across New York, while maintaining a fair and transparent competitive environment.

day lenders, and check cashing services. Yet residents wishing to open a savings account have to drive some distance to find a depository institution.

Louisiana has a state banking development district program which allows municipal deposits to be placed in new branches in banking deserts identified by local government and approved by the state. New York has a similar program, which has been used by the State to support Spring Bank, in the South Bronx. Unlike Louisiana, the New York law does not yet allow municipal deposits to be placed with credit unions. See *https://nextcity. org/daily/entry/shreveport-predatory-lending-banking-deserts*.

AHP Round To Open February 3rd

February 3rd is the date that the 2020 cycle of grants for the Affordable Housing Program of the Federal Home Loan Bank of NY opens, with applications due 45 days later. FHLBNY expects to make available more than \$35 million in this round. AHP funds can be used for creation of new affordable rental housing, or to repair and rehabilitate homes owned and occupied by lower income households. AHP funding is capped at \$40,000 per unit.

For those who have applied for AHP funding in recent years, you will note that the scoring criteria have remained the same this year. There are points available for projects that serve very low income households, as well as special needs populations. One significant change this year is that member banks are limited to submitting no more than 40 applications apiece. This change is hoped to increase the geographic spread of the program and reduce dominance by one or more financial institutions. AHP-only funded projects are eligible. Matching funds are not required, although points are awarded for leveraged projects.

FHLBNY staff began traveling throughout their service footprint providing training on the latest round in January. The presenters stressed the importance of talking to FHLBNY analysts about proposed projects or programs prior to submitting an application, and invited applicants to request appointments for consultation early in the application development process.

New York State is home to a vast array of publicly assisted affordable housing, including federally assisted multifamily rentals, public housing, Low Income Housing Tax Credit, and rural rental projects. However, many of these are at risk of losing affordability through regulatory agreement expirations, physical obsolescence, or financial operating challenges. In many communities, this stock may represent the largest source of quality affordable rental housing which, if lost, may be difficult to re-create given housing market pressures and limited public subsidy. Local decisionmakers may not always be familiar with the range of strategies avail-

able to support the preservation of affordable housing in their local jurisdictions.

Enterprise Community Partners, Inc., in partnership with the New York State Office of the Attorney General, is seeking to support public jurisdictions and public and local housing authorities and agencies outside of New York City to develop long-term targeted strategic preservation plans for distressed, at-risk, and/or expiring affordable housing portfolios. Census Plans For Homeless Count Detailed

The 2020 effort to count homeless persons as part of the 2020 Census has been scheduled. The process of service-based enumeration and enumeration at transitory locations builds on decades of work with national and community-based organizations

The effort to count people experiencing homelessness at service locations and pre-identified outdoor locations is referred to as Service-Based Enumeration (SBE). SBE will count people at shelters, soup kitchens, regularly scheduled mobile food vans and target non-sheltered outdoor locations on March 30, March 31 and April 1, 2020.

A new loan fund administered by Alternatives Federal Credit Union in Ithaca is designed to reduce recidevism by providing micro-loans to formerly incarcerated individuials re-entering the community. The funds can be used for clothing for job interviews, security or utility deposits to obtain an apartment, or for transportation during the hunt for employment. The program is a partnership between Alternatives and the Park Foundation, and relies on a referral network from local social service organizations.

Page 6 . February 1, 2020 . Rural Delivery – **RPC Wins Grant For Senior Resident Coordinator Position**

On January 15, 2020, Field Hall Foundation CEO, John Ahearn, presented Community Services Programs, Inc.'s CEO, M.T. O'Leary, with a \$50,000 check for the coordination of services for Community Services Programs, Inc.'s one hundred eighty-four senior housing residents located in Southern Dutchess County.

The Field Hall Foundation's mission is to improve the lives of older adults and their caretakers by providing grants to local not-for-profit organizations and units of government. Community Services Programs, Inc., based in Wappingers Falls, is a local not-for-profit housing and community development agency, celebrating its 45th year of service to Dutchess County. It is responsible for the management of

one-hundred eighty-four senior citizen apartments in the County. Community Services was invited by the Field Hall Foundation to submit a proposal stating the organization's need for funding and a detailed plan for how they would use the funds. The application process also included an extensive review of the organization.

As stated in the proposal, Community Services plans to address the needs of the senior citizens residing at DiMarco Place I and II Senior Residences, Meadow Ridge II Senior Residence and Highland Meadows Senior Residence. Support services, such as reliable transportation, on-site continued learning opportunities, and scheduled recreational activities will be offered to the residents. Also, to enhance

independent living and aging in place of the organization's senior residents, they will have access to an exhaustive list of local, countywide, and state-wide resources tailored to their desired needs.

The \$50,000 grant will underwrite staff costs and related expenses and is for a term of one year. The funded program of the coordination of services for senior citizens' living independently is a relatively new program and is the result of the increasing longevity of the older population and desire of seniors to be fully engaged with their surroundings. During the 2020 Legislative session, the New York State Legislature will be considering the creation of a Statewide Senior Resident Coordinator Program.
