

HUD Awards \$9.4 Million In Research Grants To Reduce Housing-Related Health Hazards

The US Department of Housing and Urban Development (HUD) awarded \$9.4 million to 13 universities and public health organizations on October 26th to improve our understanding of the longer term impact of housing interventions targeting lead and other residential hazards and improve methods to identify and control residential health hazards such as pests, injury hazards, and asthma triggers. These grants are particularly important to improve our ability to protect vulnerable populations, such as children and seniors, from exposure to these hazards.

"We remain committed to improving the health and well-being of all Americans, especially children, by creating safer and healthier homes," said HUD Secretary Ben Carson. "This research will inform HUD and our partners in our efforts to protect families and eliminate housing-related health and safety hazards."

"It's critical that we continue supporting research to develop and improve methods to create housing that supports the health of residents," said Michelle Miller, Acting Director of the Office of Lead Hazard Control and Healthy Homes. "We know that substandard housing contributes to injury and illness, which is entirely preventable."

HUD's Office of Lead Hazard Control and Healthy Homes promotes state and local efforts to eliminate dangerous lead-paint and other housing-related health and safety hazards from lower income homes, stimulate private sector investment in lead hazard control, support cutting-edge research on methods for assessing and controlling housingrelated health and safety hazards, and educate the public about the dangers of hazards in the home. The grants are being offered through HUD's Lead and Healthy Homes Technical Studies Grant Programs.

Take-aways From Conference Workshops

Participants in the Stronger Together conference workshops are getting useful bits of information:

- CARES Act funding will be coming to New York through the Bureau of Housing Services at NYS OTDA. For communities not receiving direct federal funding allocations, ESG funding will be available in two phases. Phase one funding will total \$23 million, and Phase 2 funding will total \$28 million. A streamlined shelter application is expected to be released shortly after November 1st, so be sure to check the OTDA website for updates.
- The Office of Community Renewal has submitted an amendment to the state's Action Plan to HUD and is awaiting approval. The amendment will allow HCR to begin utilizing CDBG and HOME allocations authorized under the CARES Act last Because the CARES Act funding is in response to the Covid 19 pandemic, it will be important to plan programs and projects using any funds designated as 'CV' for purposes that address Covid needs. Examples include rental assistance programs that prevent displacement of tenants once the eviction moratoriums are lifted, or

- microenterprise programs that create new job opportunities to help the unemployed.
- The Homebuyer Dream Program to assist first time homebuyers is undergoing a change to the allocation formula to strengthen the role of housing counseling agencies in providing homebuyer education services. The allocation formula will no longer be just based on First Come, First Served. The next funding round is expected to take place in the second quarter of 2021.
- The Fair and Equitable Housing Office at NYS Homes and Community Renewal has a number of worksheets available to assist housing providers to comply with new rules, such as Source of Income and Re-Entry. Review of these issues is included in routine rental project monitoring by HCR's Asset Management staff.

There are still many workshops that will take place at the Stronger Together conference through the first two weeks of November. Register at www.conference.habitatnys. org. The Stronger Together Conference is a partnership between the Rural Housing Coalition and Habitat For Humanity of New York State.

Temporary Exceptions Extended

USDA issued an extension of the temporary exceptions for the Single Family Housing Guaranteed Loan Program on October 29th. The temporary exceptions originally issued on March 27, 2020, pertaining to appraisals, repair inspections, and income verifications for the Single Family Housing Guaranteed Loan Program (SFHGLP) due to the COVID-19 pandemic have been extended until December 31, 2020 and apply to the requirements in the program handbook HB-1-3555 for new loans.

Broadband Grant Received

USDA Rural Development announced a grant to expand broadband access in Western New York on October 29th. Seneca Connect will receive \$544,000 to provide broadband service in unserved and underserved rural areas in New York. This investment is part of the \$550 million Congress allocated to the second round of the ReConnect Program.

This network will connect 928 people, five farms and a business to high-speed broadband internet in Cattaraugus, Erie and Chautauqua counties in New York. This grant will provide high-speed internet service to the Cattaraugus Reservation of the Seneca Nation.

On October 26th, USDA announced 10 Community Facilities awards to rural communities in New York, including a number of grants for vehicular equipment, plus a salt shed, a DPW building, a town office building, and a fire station.
